



ALCOHOL STATEMENT AND CONSENT FORM FOR MINORS

AS REQUIRED BY LAW

California State law prohibits the consumption of Alcoholic Beverages by minors in Limousines. There will be no Alcoholic Beverages allowed in Limousines at any time during the rental when minors are present. If the chauffeur finds that Alcohol is being, or has been consumed by minors, on their person or among their belongings in the Limousine during the rental or any Illegal. The consumption of any Alcoholic Beverage is unlawful when consumed by a minor. There will be no Alcoholic Beverages transported inside the vehicle. Also no Alcoholic Beverages will be carried in the trunk or in any other locked compartment of the vehicle. This rule shall apply to any and all other Illegal Substances.

If at any time any of the passengers are found to have in their possession, or have at any time during the course of service, been consuming any Alcohol or other Illegal Substance, the service shall be terminated. All money shall be forfeited and a parent shall be notified. The driver has the option of returning to the point of pick up or ending service at the point of infraction. With reasonable suspicion, the driver shall also have the right to examine all bags or parcels to be placed inside the vehicle to determine if they contain any Illegal Substances.

A separate signature of each passenger and a signature of a Responsible Adult on this Form are required to ride in our vehicle.

Our policies regarding Alcohol and Drugs comply with the applicable laws in state of California and are consented to on "ALCOHOL STATEMENT AND CONSENT FORM FOR MINORS" form. We appreciate your assisting us in reviewing the following additional regulations with your minor son/daughter.

All pick up and drop off locations must be predetermined and approved by the parent, or legal guardian executing this agreement. Your Chauffeur will be instructed to obtain permission of a parent or legal guardian in the event of any changes to the itinerary. A contact phone number must be provided to your chauffeur on, or prior to the date of service.

At all times the privacy divider inside limousine will be open and locked. (In case of emergency, chauffeur must have access to all passengers). The following activities and or behaviors are strictly prohibited, and any violation is subject to immediate termination of our service:

Drinking, or carrying/storing alcoholic beverages of any type inside our vehicles are prohibited;

Smoking, vaping, of tobacco products or marijuana (THC and/or CBD derivatives) or any other substances is prohibited inside of our vehicles;

Consuming or carrying any type of illegal drug is prohibited inside of our vehicles, as well as the unauthorized use or sharing of prescription medicines inside the vehicle;

Having intimate relations in our vehicles is prohibited;

Hanging any part of the body outside the windows, or moon roof is prohibited;

Vandalizing, purposely damaging, staining, purposely breaking any part of the vehicle are prohibited and subjected to additional charges for repair, estimated by professional;

All passengers enter and exit vehicle once the vehicle stops only and once passengers are given permission to exit the vehicle.

NOTE: IN THE EVENT OF ANY VIOLATION OF THE ABOVE REGULATIONS, OUR CHAUFFEUR WILL IMMEDIATELY SUSPEND/TERMINATE THE SERVICE AND NOTIFY THE DESIGNATED "RESPONSIBLE ADULT", AND DROP OFF ALL PASSENGERS AT THE INITIAL PICKUP POINT, OR NEAREST POLICE STATION. NO REFUND WILL BE MADE AND PARENTS SHALL BE RESPONSIBLE FOR ADDITIONAL DIRECT COSTS.

This form is for each minor passenger, to signed by a parent, or legal guardian of the minor that gives permission for that minor to be transported to or from the event or activity. The minor shall sign this form agreeing to abide by the policies stated herein.

STEP 1: Make sure every student/pupil that is riding in the hired vehicle has this form signed by his or her parent or legal guardian.

STEP 2: Student must provide this form to the chauffeur before entering hired vehicle. NO ONE WILL BE ALLOWED IN THE VEHICLE WITHOUT THIS FORM.
